AN ORDINANCE APPROVING THE ANNUAL BUDGET AND APPROPRIATIONS FOR THE CITY OF BRAIDWOOD FOR THE FISCAL YEAR BEGINNING MAY 1, 2023 AND ENDING APRIL 30, 2024

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BRAIDWOOD OF WILL AND GRUNDY COUNTIES AND STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1: BUDGET AND APPROPRIATIONS

That the sums, or so much thereof as hereby may be authorized by law, as set forth in Exhibit A attached hereto be and the same are hereby budgeted and appropriated to pay all necessary expenses and liabilities of the City of Braidwood, Illinois, for the fiscal year beginning May 1, 2023, and ending April 30, 2024. Such appropriations are hereby made for the objects and purposes as set forth in Exhibit A.

SECTION 2: ANNUAL BUDGET

That the annual budget attached hereto as Exhibit A and made a part hereof is an estimate of revenues by source anticipated to be received by the City of Braidwood for the fiscal year May 1, 2023, to April 30, 2024.

SECTION 3: ADOPTED PURSUANT TO THE ILLINOIS MUNICIPAL CODE

That this Budget and Appropriations Ordinance is adopted pursuant to procedures set forth in the Illinois Municipal Code.

SECTION 4: ORDINANCE TO BE FILED WITH COUNTY CLERK

That a certified copy of this Ordinance shall be filed with the county clerk within 30 days after adoption.

SECTION 5: SEVERABILITY

That if any section, subdivision, or sentence of this Ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion and provisions of this Ordinance.
